



SECOND INTERNATIONAL WORKSHOP ON PELLET SAFETY

5-7 May 2014, Fügen, Austria

Following on from the huge success of the first workshop on pellet safety last year, the European Pellet Council (EPC), in cooperation with the SafePellets project, the European Industry of Pellet Suppliers (EIPS), and the International Biomass Torrefaction Council (IBTC) would like to invite you to the 2nd International Workshop on Pellet Safety, taking place on the 5-7 May 2014 in Fügen, Austria. This workshop will be chaired by Mr. Christian Rakos, EPC President and will be held in the same venue as last year.

Overview:

The manufacturing, handling and use of woodpellets or pellets from torrefied biomass pose serious safety issues. Wood dust can lead to explosions and fires, pellets in storage can heat up, generate CO and even self-ignite. Safety and health issues can also occur in the supply chain and during the end use as fuel in power plants and heating devices. Hence, there is a clear need to have a better understanding of these issues in order to prevent it. This second international workshop on pellet safety is organised with this purpose.

The workshop will proceed in two parts. The first part will be dedicated to formal presentations. These will include presentations of the results of the SafePellets project, presentations of safety experts on incidents and learnings and reports on the follow up activities that were proposed during the first international pellet safety workshop. The second part will be organized as open space workshop ensuring maximum interaction and focus on the topics participants are most interested in.
